2. Nomination Rationale. Please provide a concise statement as to the reason this person or organization should receive the award for the specified category.
3. Nominator's Relationship to the Nominee. Please share with us how you know the nominee.
4. Contact Information for the Nominator. As the nominator, include your name, mailing address, email address, and phone number.

Nominations may be submitted on the provided form either FAXED (419-462-5487) or brought to the Chamber Office by 4 PM on April 17, 2015.

The nominations will be reviewed by a selection committee of the Galion Area Betterment Commission.

Award winners will be invited to the Galion-Crestline Area Chamber of Commerce Annual Membership Meeting at the Free Methodist Church's Christian Life Center on Portland Way North at 7:30 AM on May 12, 2015. The Awards will be presented immediately after the Chamber Meeting.

DESCRIPTION OF CATEGORIES

1) The “ Citizen of the Year Award,” is presented annually to an individual who either resides or works in the Galion Area. This person should also exhibit a quality of life that promotes the community of Galion. The Commission seeks to recognize those who have provided exemplary service to the Galion Community during the past year.

2) The “Organization of the Year” award is presented annually to the non-profit group or agency that provides a unique and/or special service to the Galion Community/Area during the past year. The service of the group, should also be in keeping with the highest of standards and ideals of the Galion Area.

3) The “Humanitarian of the Year” recipient is one who will have responded to a human hurt or need in a significant and often self – sacrificing manner. The award is presented annually when it is determined that an individual/s who reside or work in the Galion Area, has responded in this way during the past year.
