The jurors of the grand jury of the State of Ohio, within and for the body of the County aforesaid, on their oaths, in the name and by the authority of the State of Ohio, do find and present that **LINDA S. BUCKNER** did commit the crime(s) of:

COUNT 1: AGGRAVATED ROBBERY

On or about 07/04/2015 and between on or about 07/13/2015, at the County of Richland, Ohio, did, in attempting or committing a theft offense, or in fleeing immediately after the attempt or offense, did, inflict, attempt to inflict, or threaten to inflict serious physical harm on another, in violation of section 2911.01(A)(3) of the Ohio Revised Code, a felony of the first degree.

COUNT 2: ROBBERY

On or about 07/04/2015 and between on or about 07/13/2015, at the County of Richland, Ohio, did, in attempting or committing a theft offense, or in fleeing immediately after the attempt or offense, did, inflict, attempt to inflict, or threaten to inflict physical harm on another, in violation of section 2911.02(A)(2) of the Ohio Revised Code, a felony of the second degree.

COUNT 3: AGGRAVATED BURGLARY

On or about 07/04/2015 and between on or about 07/13/2015, at the County of Richland, Ohio, by force, stealth, or deception, did trespass in an occupied structure, or in a separately secured or separately occupied portion of an occupied structure, when another person other than an accomplice of the offender is present, with purpose to commit in the structure or in the separately secured or separately occupied portion of the structure any criminal offense, and the offender inflicts, or attempts or threatens to inflict bodily harm on another, in violation of section 2911.11(A)(1) of the Ohio Revised Code, a felony of the first degree.

COUNT 4: BURGLARY

On or about 07/04/2015 and between on or about 07/13/2015, at the County of Richland, Ohio, did, by force, stealth, or deception, trespass in an occupied structure, or in a separately secured or separately occupied portion of an occupied structure, when another person other than an accomplice of the offender is present, with purpose to commit in the structure or in the separately secured or separately occupied portion of the structure any criminal offense, in violation of section 2911.12(A)(1) of the Ohio Revised Code, a felony of the second degree.

COUNT 5: BURGLARY

On or about 07/04/2015 and between on or about 07/13/2015, at the County of Richland, Ohio, did, by force, stealth, or deception, trespass in an occupied structure or in a separately secured or separately occupied portion of an occupied structure, with purpose to commit in the structure or separately secured or separately occupied portion of the structure any criminal offense, in violation of section 2911.12(A)(3) of the Ohio Revised Code, a felony of the third degree.

COUNT 6: ABUSE OF A CORPSE

On or about 07/04/2015 and between on or about 07/13/2015, at the County of Richland, Ohio, except as authorized by law, did treat a human corpse in a way that would outrage reasonable community sensibilities, in violation of section 2927.01(B) of the Ohio Revised Code, a felony of the fifth degree

COUNT 7: TAMPERING WITH EVIDENCE

On or about 07/04/2015 and between on or about 07/13/2015, at the County of Richland, Ohio, knowing that an official proceeding or investigation was in progress, or was about to be or likely to be instituted, did alter, destroy, conceal, or remove any record, document, or thing, with purpose to impair its value or availability as evidence in such proceeding or investigation, in violation of section 2921.12(A)(1) of the Ohio Revised Code, a felony of the third degree.

COUNT 8: TAMPERING WITH EVIDENCE

On or about 07/04/2015 and between on or about 02/06/2016, at the County of Richland, Ohio, knowing that an official proceeding or investigation was in progress, or was about to be or likely to be instituted, did alter, destroy, conceal, or remove any record, document, or thing, with purpose to impair its value or availability as evidence in such proceeding or investigation, in violation of section 2921.12(A)(1) of the Ohio Revised Code, a felony of the third degree.

COUNT 9: RECEIVING STOLEN PROPERTY

On or about 07/04/2015 and between on or about 02/04/2016, at the County of Richland, Ohio, did receive, retain, or dispose of property of another, knowing or having reasonable cause to believe said property had been obtained through commission of a theft offense, the property involved is any of the property listed in section 2913.71 of the Ohio Revised Code, in violation of section 2913.51(A) of the Ohio Revised Code, a felony of the fifth degree.

COUNT 10: MISUSE OF CREDIT CARD

On or about 07/04/2015 and between on or about 02/04/2016, at the County of Richland, Ohio, with purpose to defraud, did obtain property or services by the use of a credit card, in one or more transactions, knowing or having reasonable cause to believe that the card has expired or been revoked, or was obtained, is retained, or is being used in violation of law, the victim being an elderly person or disabled adult, the cumulative retail value of the property or services involved being one thousand dollars (\$1,000) or more but less than seven thousand five hundred dollars (\$7,500), in violation of section 2913.21(B)(2)&(D)(4) of the Ohio Revised Code, a felony of the fourth degree.

Contrary to the form of the statute in such case made and provided, and against the peace and dignity of the State of Ohio.
