It is my belief and has been for some time, that an elected official in Mansfield, OH. John Randolph Spon, Law Director for the city of Mansfield, lives outside the city limits of Mansfield and is in violation of the following Ohio Election Law.

https://www.ohiosos.gov/globalassets/elections/directives/2019/dir2019-11_eom.pdf, states "The place where the family of a married man or woman resides shall be considered to be their place of residence, except that when the husband and wife have separated and live apart, the place where they resides the length of time required to entitle a person to vote shall be considered to be their place of residence."

Mr. Spon, by his voting records, states he resides at 1568 Lexington Ave. Apt 4-A Mansfield, OH 44907 and has voted at Resurrection Parish in Ward 1-A for over 8 years.

Mrs. Dusty Ann Spon, by her voting record, states she resides at 480 Cedarwood Dr, Lexington, OH 44904 and has voted at Heartland Church in Precinct Lex C. She has also voted in her precinct for over 8 years


Mr and Mrs Spon are not separated or divorced and they reside as a couple at 480 Cedarwood Dr. Lexington, OH 44904.




