On behalf of the City of Shelby, I, Mayor Steven L. Schag, and members of the rural community hereby respectfully present the Richland County Board of Commissioners with a Ditch Petition for the Black Fork River.

The proposed cleaning and maintenance designation for the petition is from the Mickey Road bridge, Shelby, Sharon Township, Richland County to the eastern edge of the water course bridge at State Route 13, Franklin Township, Richland County.

The petition represents 10,457 total parcels covering the Black Fork River watershed area in Richland and Crawford Counties.

We, the petitioners, respectfully request the Board of Commissioners to examine and study the economic benefits to the City of Shelby and the approximately 70,000 acres of the agricultural community that lie within the petitioned watershed area.

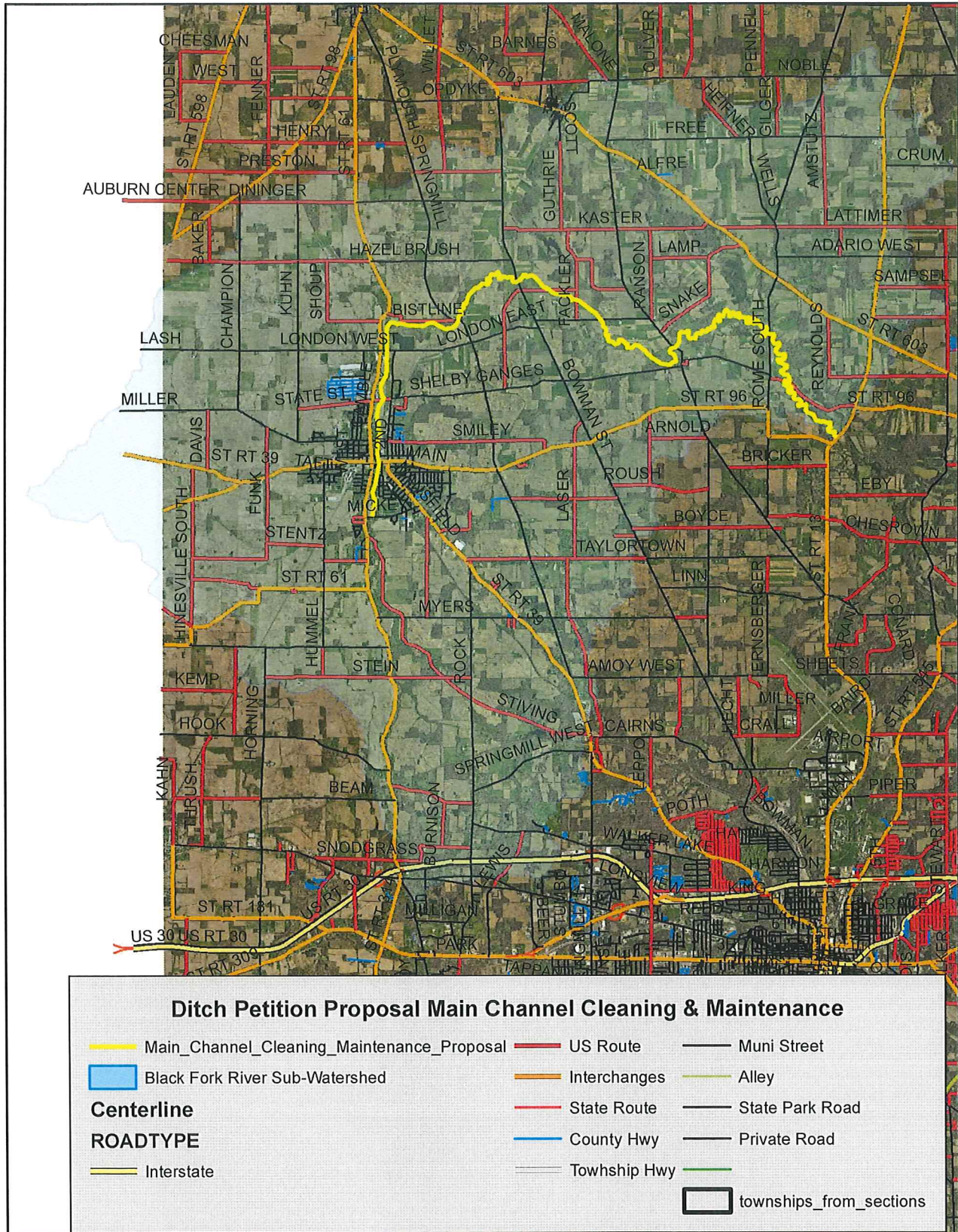

Joint County Ditch Petition

Ohio Revised Code 6131.04; 6133.02 and 6133.03

To the Board of County Commissioners, Richland County, Ohio, on this day of February 24, 2021

The undersigned hereby petition your honorable body to: 1) remove brush, log jams, tree piles, leaning trees, felled trees, and dead trees from within and along the banks of the river 2) necessary bank armoring or stabilization, 3) any additional duties deemed necessary by the County Engineer and the Board of Supervisors of the Richland Soil and Water Conservation District; including but not limited to the removal of silt bars and brush piles, and the removal of trees, debris, and brush 20 feet back from the top of the bank, except whereas trees or structures are designated to remain standing 4) and maintain the waterway from the said obstructions thereafter to the course set forth.

The construction of the improvement is necessary, and will be conducive to the public welfare. The following is the course and termini of said improvement, to wit:

Commencing on the Black Fork River, 50 feet south of the Mickey Road bridge, Sharon Township, Shelby City, Richland County, Ohio to the eastern edge of the water course bridge located at Ohio State Route 13, Franklin Township, Richland County, Ohio.

The exact length of the water course stated herein shall be determined by the Richland County Engineer at the time of the survey and design of the proposed ditch petition.

All cost of construction, engineering, and future maintenance shall be assessed to the benefiting parcels of land within the watershed area determined by the Richland County Engineer.

A list of names and addresses, where known, of all landowners which the Petitioner claims will be benefited or damaged by the construction of the proposed improvement, is attached hereto.

Service of notice of the filing of the Petition shall be obtained by mailing notices and publications as provided in R. C. Sec. 6131.07. See attached hereto.
