CERTIFICATE OF APPOINTMENT OF MEMBER OF THE MANSFIELD METROPOLITAN HOUSING AUTHORITY

WHEREAS, Section 3735.27 of The Ohio Revised Code requires that the mayor of the most populous city in the territory of the Mansfield Metropolitan Housing Authority appoint two members of said Authority, and
