How was this created?

- Richland County and other communities received an allocation of the CARES Act federal funds. The Commissioners approached the Chamber in July to work with them to create a small business grant fund because they knew many small businesses were still struggling.
- The County Commissioners approved \$250,000 to be granted to businesses in Richland County at their August 19th meeting.
- Mansfield City Council approved \$250,000 to be granted to businesses in Mansfield at the September 1, 2020 Council meeting.
- City of Shelby approved \$90,000 to be granted to businesses in Shelby on September 21, 2020.
- City of Ontario approved \$25,000 to be granted to businesses in Ontario on September 16, 2020.
- Village of Plymouth approved \$26,500 to be granted to businesses in Plymouth on September 8, 2020.
- Village of Lexington approved \$37,500 to be granted to businesses in Lexington on October 5, 2020.
- Village of Bellville approved \$18,000 to be granted to businesses in Bellville on October 5, 2020.
- Additional funds were given by Richland County, City of Mansfield, and City of Ontario for Round 1.

Round 1 Eligibility:

- Must be a for-profit business in Richland County.
- Any form of business is eligible (e.g. Corporation, LLC, LLP) – if not a sole prop then the business must be registered with the Secretary of State's office.
- In operation prior to September 1, 2019 (will need a 2019 business tax return or Schedule C)
- Business must have \$1,500,000 or less in gross income for 2019.
- Business must provide their EIN or the SSN numbers of owners with more than 20% stake.
- Business must have 20 FTE's or less
 - A full-time (40 hrs) employee counts as 1 FTE
 - A part-time employee (less than 40 hrs) counts as $\frac{1}{2}$ FTE
 - A 1099 contractor is looked at like an employee using the above definitions as FTEs.
- Businesses with 2-20 FTE's have a maximum grant amount of \$7,500
- Businesses with less than 2 FTE's have a maximum grant amount of \$2,500.





Round 1 Grant Funding Sources by dollars




Round 1: Grants by Location of Business (Amount Awarded)




Round 1: Awarded Dollars by Applicant Size




Round 1: Awards by Length of Time in Business (total Count)



Round 1: Awards by % of Financial Impact of COVID




Round 1: Grants Awarded by # of Employees





ROUND 2

Round 2 Eligibility

- Must be a for-profit business in Richland County OR one of the following types of non-profits: 501c4, 501c6, 501c7, 501c19, 501c23
- Any form of business is eligible (e.g. Corporation, LLC, LLP) – if not a sole prop then the business must be registered with the Secretary of State's office.
- In operation prior to February 28, 2020 (will need to show proof of existence)
- Business must have \$4,000,000 or less in revenues for 2019.
- Business must provide their EIN or the SSN numbers of owners with more than 20% stake.
- Business must have 40 FTE's or less
 - A full-time (40 hrs) employee counts as 1 FTE
 - A part-time employee (less than 40 hrs) counts as $\frac{1}{2}$ FTE
 - A 1099 contractor is looked at like an employee using the above definitions as FTEs.
 - The owner or partner who actively works in the business should be counted in the employee count.
- Businesses with 2-40 FTE's have a maximum grant amount of \$7,500
- Businesses with less than 2 FTE's have a maximum grant amount of \$2,500.





Round 2 Grant Funding Sources by Dollars




Round 2: Grants by Location of Business (Amount Awarded)




Round 2: Awarded Dollars by Applicant Size




Round 2: Awards by Length of Time in Business (total Count)



Round 2: Awards by % of Financial Impact of COVID




Round 2: Grants Awarded by # of Employees




