Authorizing the Safety Service Director to accept and appropriate a donation of One Thousand and 00/100 (\$1,000.00) from the Wal-Mart Smart Good Program for the Mansfield Police Department Neighborhood Impact Section.

**BE IT ORDAINED BY THE COUNCIL OF THE  
CITY OF MANSFIELD, STATE OF OHIO:**

SECTION 1. That the Safety Service Director be, and is hereby, authorized to accept a donation in the amount of One Thousand and 00/100 dollars (\$1,000.00) from Wal-Mart Smart Good Program to be used for the Mansfield Police Department Neighborhood Impact Section

SECTION 2. That the sum of One Thousand and 00/100 dollars (\$1,000.00) be, and the same is hereby, appropriated from the unappropriated Safety-Service Fund (#214) to the Police Department Operation #214.15.01 – Supplies and Materials Classification.

SECTION 3. That being an appropriation necessary for current expenses, this ordinance shall take effect and be in full force immediately upon its passage and approved by the Mayor.
