**Count One: Felonious Assault**

*The Jurors of the Grand Jury of the State of Ohio, within and for the body of Richland County, on their oaths, in the name and by the authority of the State of Ohio, do find and present:*

Tyler Garrett, on or about the 8th day of May, 2025, at the county of Richland aforesaid, did knowingly cause serious physical harm to [REDACTED] in violation of Ohio Revised Code §2903.11(A) (1), 2903.11(D)(1)(a), **Felonious Assault**, a felony of the second degree.

**Repeat Violent Offender Specification, "RVO" - Multiple Convictions - §2941.149(A)**

*The Grand Jurors further find and specify that:*

Tyler Garrett was convicted of or pleaded guilty to Robbery, to wit: on or about 05/10/2016, in the COURT OF COMMON PLEAS, HAMILTON County, Ohio, in violation of R.C. 2911.02, in B 1502859, and Aggravated Burglary, Kidnapping and Rape, to wit: on or about 01/02/2024, in the COURT OF COMMON PLEAS, HAMILTON County, Ohio, in violation of R.C. 2911.11 ((A)(2), 2905.01(A)(2) and 2907. 02(A)(2), in B 2200130.

*The offense is contrary to the form of the statute in such case made and provided, and against the peace and dignity of the State of Ohio.*

**Count Two: Assault**

*The Grand Jurors do further find and present:*

Tyler Garrett, on or about the 8th day of May, 2025, at the county of Richland aforesaid, did knowingly cause or attempt to cause physical harm to [REDACTED] in violation of Ohio Revised Code §2903.13(A), 2903.13(C)(3), **Assault**, a felony of the third degree.

FURTHERMORE, the offense occurred in or on the grounds of a state correctional institution, the victim of the offense was an employee of the department of rehabilitation and correction, and the offense was committed by a person incarcerated in the state correctional institution.


**Repeat Violent Offender Specification - §2941.149(A)**

*The Grand Jurors further find and specify that:*

Tyler Garrett is a Repeat Violent Offender in that Tyler Garrett previously was convicted of or pleaded guilty to committing or complicity in committing aggravated murder, murder, a felony of the first or second degree that was an offense of violence, or an attempt to commit any of these offenses when the attempt was a felony of the first or second degree, or an offense under an existing or former law of this state, another state, or the United States that is or was substantially equivalent, to wit: 01/02/2024 in COURT OF COMMON PLEAS, HAMILTON, of R.C. 2911.11((A)(2), 2905.01(A)(2) and 2907.02(A)(2), Aggravated Burglary, Kidnapping and Rape, in B 2200130.

*The offense is contrary to the form of the statute in such case made and provided, and against the peace and dignity of the State of Ohio.*


