Count One: Attempted Murder

The Jurors of the Grand Jury of the State of Ohio, within and for the body of Richland County, on their oaths, in the name and by the authority of the State of Ohio, do find and present:

LENAEL TROY SMITH, on or about the 18th day of July, 2025, at the county of Richland aforesaid, did attempt to purposely cause the death of [REDACTED] in violation of Ohio Revised Code §2923.02 / §2903.02(A), 2903.02(D), 2929.02(B), **Attempted Murder**, a felony of the first degree.

The offense is contrary to the form of the statute in such case made and provided, and against the peace and dignity of the State of Ohio.

Count Two: Rape

The Grand Jurors do further find and present:

LENAEL TROY SMITH, on or about the 18th day of July, 2025, at the county of Richland aforesaid, did engage in sexual conduct with [REDACTED] when LENAEEL TROY SMITH purposely compelled her to submit by force or threat of force in violation of Ohio Revised Code §2907.02 (A)(2), 2907.02(B), **Rape**, a felony of the first degree.

The offense is contrary to the form of the statute in such case made and provided, and against the peace and dignity of the State of Ohio.

Count Three: Kidnapping

The Grand Jurors do further find and present:

LENAEL TROY SMITH, on or about the 18th day of July, 2025, at the county of Richland aforesaid, did, by force, threat, or deception, under circumstances that created a substantial risk of serious physical harm to [REDACTED] knowingly restrain[REDACTED] of her liberty in violation of Ohio Revised Code §2905.01(B)(2), 2905.01(C)(1), **Kidnapping**, a felony of the first degree.

The offense is contrary to the form of the statute in such case made and provided, and against the peace and dignity of the State of Ohio.

Count Four: Abduction

The Grand Jurors do further find and present:

LENAEL TROY SMITH, on or about the 18th day of July, 2025, at the county of Richland aforesaid, did, without privilege to do so, knowingly, by force or threat, restrain the liberty of [REDACTED] under circumstances that created a risk of physical harm to her or placed her in fear in violation of Ohio Revised Code §2905.02(A)(2), 2905.02(C), **Abduction**, a felony of the third degree.

The offense is contrary to the form of the statute in such case made and provided, and against the peace and dignity of the State of Ohio.

Count Five: Felonious Assault

The Grand Jurors do further find and present:

LENAEL TROY SMITH, on or about the 18th day of July, 2025, at the county of Richland aforesaid, did knowingly cause serious physical harm to [REDACTED] in violation of Ohio Revised Code §2903.11(A)(1), 2903.11(D)(1)(a), **Felonious Assault**, a felony of the second degree.

The offense is contrary to the form of the statute in such case made and provided, and against the peace and dignity of the State of Ohio.

Count Six: Strangulation

The Grand Jurors do further find and present:

LENAEL TROY SMITH, on or about the 18th day of July, 2025, at the county of Richland aforesaid, did knowingly cause serious physical harm to [REDACTED] by means of strangulation or suffocation in violation of Ohio Revised Code §2903.18(B)(1), 2903.18(C)(1), **Strangulation**, a felony of the second degree.

The offense is contrary to the form of the statute in such case made and provided, and against the peace and dignity of the State of Ohio.

Count Seven: Strangulation

The Grand Jurors do further find and present:

LENAEL TROY SMITH, on or about the 18th day of July, 2025, at the county of Richland aforesaid, did knowingly create a substantial risk of serious physical harm to [REDACTED] by means of strangulation or suffocation in violation of Ohio Revised Code §2903.18(B)(2), 2903.18(C)(2), **Strangulation**, a felony of the third degree.

The offense is contrary to the form of the statute in such case made and provided, and against the peace and dignity of the State of Ohio.

Count Eight: Strangulation

The Grand Jurors do further find and present:

LENAEL TROY SMITH, on or about the 18th day of July, 2025, at the county of Richland aforesaid, did knowingly cause or create a substantial risk of physical harm to [REDACTED] by means of strangulation or suffocation in violation of Ohio Revised Code §2903.18(B)(3), 2903.18(C)(3), **Strangulation**, a felony of the fifth degree.

The offense is contrary to the form of the statute in such case made and provided, and against the peace and dignity of the State of Ohio.

Count Nine: Having Weapons While Under Disability

The Grand Jurors do further find and present:

LENAEL TROY SMITH, on or about the 18th day of July, 2025, at the county of Richland aforesaid, did knowingly acquire, have, carry, or use a firearm or dangerous ordnance when he was under indictment for or had been convicted of a felony offense involving the illegal possession, use, sale, administration, distribution, or trafficking in any drug of abuse, to wit: on or about May 5, 2008, in the Mansfield Common Pleas Court, Richland County, Ohio, Possession of Cocaine, in violation of 2925.11(A), in 2007 CR 0389 in violation of Ohio Revised Code §2923.13(A)(3), 2923.13(B), **Having Weapons While Under Disability**, a felony of the third degree.

Specification for Forfeiture of a Weapon - §2941.1417(A)

The Grand Jurors further find and specify that:

LENAEL TROY SMITH is the owner and/or possessor of a Rossi Revolver, Serial Number: [REDACTED] which was contraband and/or property derived from or through the commission or facilitation of the offense, and/or was an instrumentality the offender used or intended to use in the commission or facilitation of the offense.

The offense is contrary to the form of the statute in such case made and provided, and against the peace and dignity of the State of Ohio.

Count Ten: Having Weapons While Under Disability

The Grand Jurors do further find and present:

LENAEL TROY SMITH, on or about the 18th day of July, 2025, at the county of Richland aforesaid, did knowingly acquire, have, carry, or use a firearm or dangerous ordnance when he was under indictment for or had been convicted of a felony offense involving the illegal possession, use, sale, administration, distribution, or trafficking in any drug of abuse, to wit: on or about May 5, 2008, in the Mansfield Common Pleas Court, Richland County, Ohio, Possession of Cocaine, in violation of 2925.11(A), in 2007 CR 0389 in violation of Ohio Revised Code §2923.13(A)(3), 2923.13(B), **Having Weapons While Under Disability**, a felony of the third degree.

Specification for Forfeiture of a Weapon while under Disability - §2941.1417(A)

The Grand Jurors further find and specify that:

LENAEL TROY SMITH is the owner and/or possessor of a Ruger Pistol, Serial Number: [REDACTED] which was contraband and/or property derived from or through the commission or facilitation of the offense, and/or was an instrumentality the offender used or intended to use in the commission or facilitation of the offense.

The offense is contrary to the form of the statute in such case made and provided, and against the peace and dignity of the State of Ohio.

Count Eleven: Having Weapons While Under Disability

The Grand Jurors do further find and present:

LENAEL TROY SMITH, on or about the 18th day of July, 2025, at the county of Richland aforesaid, did knowingly acquire, have, carry, or use a firearm or dangerous ordnance when he was under indictment for or had been convicted of a felony offense involving the illegal possession, use, sale, administration, distribution, or trafficking in any drug of abuse, to wit: on or about May 5, 2008, in the Mansfield Common Pleas Court, Richland County, Ohio, Possession of Cocaine, in violation of 2925.11, in 2007 CR 0389 in violation of Ohio Revised Code §2923.13(A)(3), 2923.13(B), **Having Weapons While Under Disability**, a felony of the third degree.

Specification for Forfeiture of a Weapon while under Disability - §2941.1417(A)

The Grand Jurors further find and specify that:

LENAEL TROY SMITH is the owner and/or possessor of a Smith and Wesson Pistol, Serial Number: [REDACTED] which was contraband and/or property derived from or through the commission or facilitation of the offense, and/or was an instrumentality the offender used or intended to use in the commission or facilitation of the offense.

The offense is contrary to the form of the statute in such case made and provided, and against the peace and dignity of the State of Ohio.


